
Pursuant to Section 23 of the Penal Code, Petitioner, Stephanie Nunez, in her official capacity as the Executive Officer of the Respiratory Care Board (Petitioner) appeared on August 15, 2013, at 8:30 a.m., in Department 63 of the above-entitled court to make recommendations to this court pertaining to defendant Santiago Alvarez' license to practice respiratory care in California pending the resolution of the above-captioned criminal matter. Petitioner appeared through counsel, California Attorney General Kamala D. Harris, by Deputy Attorney General Lori J. Forcucci; Defendant Santiago Alvarez appeared and was represented by his Deputy Public Defender.

1 After considering the pleadings filed in connection with the Penal Code Section 23 petition,  
2 hearing the arguments of counsel, and good cause appearing therefore, it is hereby ordered that,  
3 as a condition of any bail, own recognizance release, defendant Santiago Alvarez' Respiratory  
4 Care Practitioner License No. 12108 shall be suspended until the criminal charges pending  
5 against him in Case No. RIF 1301322 are fully resolved. If defendant is placed on probation, as a  
6 condition of probation, defendant Santiago Alvarez' Respiratory Care Practitioner License  
7 No. 12108 shall be suspended for the full term of the probation imposed.
