

## Continuing Education Earned for Meeting Attendance

If you would like to receive CE credit for attending our meeting today, you must **SIGN IN** in with your time of arrival **AND SIGN OUT** with your time of departure. CE credit will be for the actual hours, in full hour increments, while in attendance at the board meeting. Partial hour credit will not be given. Verification of hours awarded will be emailed to you within 30 days following the meeting.

**If your next RCP license renewal is on or after 12/31/25,  
you may use the CE earned today to meet your CE requirements as follows:**

Two-Year Renewal Cycle CE Requirements for all license renewals on or after 12/31/25:

15 CE Hours in Clinical Practice

10 CE Hours in Leadership

5 CE Hours of any of the above or indirectly related to respiratory care (e.g. attendance at board meetings)

30 Total CE Hours Required

15 out of the total 30 required CE hours must be obtained through live courses or meetings, which include online activities that involve live interaction between course providers and students.

- ➡ **Hours earned for attending this board meeting will count toward CE "indirectly related to respiratory care" and the "live hours" requirement.**

**If your next RCP license renewal is prior to 12/31/25,  
you may still use the CE earned today to meet your CE requirements as follows:**

Two-Year Renewal Cycle CE Requirements for all license renewals prior to 12/31/25:

20 CE Hours in Clinical Practice

10 CE Hours directly or indirectly related to respiratory care (e.g. attendance at board meetings)

30 Total CE Hours Required (No "live" course requirement)

- ➡ **Hours earned for attending this board meeting will count toward CE "indirectly related to respiratory care."**

**If you were initially licensed in the last 24 months, you may  
use the CE earned today to meet your CE requirements as follows:**

If your first renewal since initial licensure is on or after 12/31/25, your CE requirements are:

7 CE Hours in Clinical Practice

5 CE Hours in Leadership

3 CE Hours of any of the above or indirectly related to respiratory care (e.g. attendance at board meetings)

15 Total CE Hours Required

7 out of the total 15 required CE hours must be obtained through live courses or meetings, which include online activities that involve live interaction between course providers and students.

- ➡ **Hours earned for attending this board meeting will count toward CE "indirectly related to respiratory care" and the "live hours" requirement.**

If your first renewal since initial licensure is before 12/31/25, your CE requirements are:

10 CE Hours in Clinical Practice

5 CE Hours of any of the above or indirectly related to respiratory care (e.g. attendance at board meetings)

15 Total CE Hours Required (No "live course requirement")

- ➡ **Hours earned for attending this board meeting will count toward CE "indirectly related to respiratory care."**
