REYES, ROGER - RCP 35843

Failed to comply with Board-ordered probation by failing to set up account and call for biological fluid testing, failed to submit quarterly reports, failed to pay probation monitoring costs, failed to pay cost recovery, and failed to maintain a valid license. Pursuant to a Stipulated Surrendered of License and Disciplinary Order, license surrendered effective April 6, 2017.

WREN, RANDY LEE - RCP 14678

Charged with committing coercion and enticement of a minor in illicit sexual conduct. Pursuant to a Default Decision and Order, license revoked effective April 22, 2017. View Documents

LETELLIER, TYLER SEAN - RCP 29450

Committed acts of negligence and unprofessional conduct in that he failed to provide and document an evaluation score and clinical note before discontinuing or decreasing respiratory therapy to four patients. Pursuant to a Stipulated Settlement and Disciplinary Order, license publicly reproved effective April 24, 2017.

GIDEON, JESSICA J - RCP 27073

Failed to comply with Board-ordered probation by failing to comply with biological fluid testing requirements, failing to obey all laws, failing to abstain from the use of alcohol, and failing to pay probation monitoring costs and cost recovery. Pursuant to a Decision proposed by an Administrative Law Judge, license revoked effective April 29, 2017.

Failed to comply with Board-ordered probation by failing to participate in biological fluid testing and failing to pay probation monitoring costs and cost recovery. Pursuant to a Decision proposed by an Administrative Law Judge, license revoked effective May 9, 2017.

EXPLANATION OF DISCIPLINARY LANGUAGE AND ACTIONS

Effective date of decision:

The date the disciplinary decision goes into operation.

Default Decision:

A decision based on the licensee's failure to respond to formal charges after it has been served, or failure to appear at an Administrative Hearing. All charges are deemed true. The decision results in the revocation of the license.

Disciplinary Order:

An order for discipline adopted by the Board.

Probation:

Allows the licensee to practice as a respiratory care practitioner under terms and conditions for a set amount of time.

Proposed Decision:

A decision rendered by an Administrative Law Judge through an Administrative Hearing. A proposed decision must be adopted by the Board before it can go into effect.

Public Reproval:

A lessor form of discipline that can be negotiated after or in lieu of the filing of formal charges. The reprimand may include educational and clinical training requirements.

Revoked:

The right to practice is ended due to disciplinary action. The license is invalidated, voided, annulled, or rescinded. The individual can no longer practice as a respiratory care practitioner in California.

Revoked, Stayed:

"Stayed" means the revocation is postponed.

Professional practice may continue so long as the licensee complies with specified terms and conditions of probation

Stipulated Settlement:

A form of plea bargaining. The case is formally negotiated and settled prior to a hearing.

Stipulated Surrendered:

The Board agrees to allow the licensee to surrender the license as a resolution to a disciplinary matter. The individual can no longer practice as a respiratory care practitioner in California.

TREDE. GLENN WAYNE - RCP 26089

Convicted of knowingly receiving visual depictions that are digital and computer images of a minor engaging in sexually explicit conduct. Pursuant to a Default Decision and Order, license revoked effective May 24, 2017.

Failed to comply with Board-ordered probation by failing to participate in biological fluid testing, failing to pay probation monitoring fees and cost recovery, and failing to maintain a valid license status.
