## MEZA, PAUL ANTHONY – RCP 27327

Convicted of recklessly fleeing a police officer, misuse of alcohol in a dangerous manner, and prior discipline for convictions of driving under the influence of alcohol and receiving/buying known stolen property. Pursuant to a Default Decision and Order, license revoked effective April 4, 2018.

## ROGERS, SHAUN ADAM – RCP 27913

Committed acts of unprofessional conduct by making inappropriate comments to a female patient while rendering care and treatment. Pursuant to a Stipulated Settlement and Disciplinary order for Public Reprimand, license publicly reprimanded effective April 5, 2018.

## MARSH, COREEN LEANN – RCP 36657

Convicted of driving under the influence of alcohol with a prior undisclosed conviction of disturbing the peace. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective April 12, 2018.

## SALCIDO BUNDY, ANDREANA – RCP 32721

Convicted of driving under the influence of alcohol and use of alcohol in a dangerous manner. Pursuant to a Stipulated Surrender of License and Order, license surrendered effective May 5, 2018.

## LANE, NATHAN CHANCE – RCP 31341

Convicted of intimidating a witness or victim with a prior conviction of driving under the influence of alcohol. Pursuant to a Default Decision and Order, license revoked effective May 9, 2018.

## EXPLANATION OF DISCIPLINARY LANGUAGE AND ACTIONS

**Effective date of decision:** The date the disciplinary decision goes into operation.

**Default Decision:** A decision based on the licensee's failure to respond to formal charges after it has been served, or failure to appear at an Administrative Hearing. All charges are deemed true. The decision results in the revocation of the license.

**Disciplinary Order:** An order for discipline adopted by the Board.

**Probation:** Allows the licensee to practice as a respiratory care practitioner under terms and conditions for a set amount of time.

**Proposed Decision:** A decision rendered by an Administrative Law Judge through an Administrative Hearing. A proposed decision must be adopted by the Board before it can go into effect.

**Public Reprimand:** A lesser form of discipline that can be negotiated after or in lieu of the filing of formal charges. The reprimand may include educational and clinical training requirements.

**Revoked:** The right to practice is ended due to disciplinary action. The license is invalidated, voided, annulled, or rescinded. The individual can no longer practice as a respiratory care practitioner in California.

**Revoked, Stayed:** "Stayed" means the revocation is postponed. Professional practice may continue so long as the licensee complies with specified terms and conditions of probation.

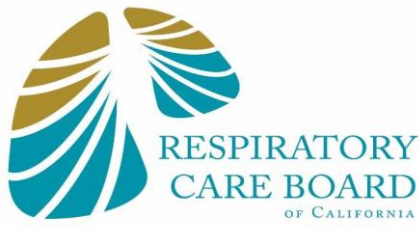
**Stipulated Settlement:** A form of plea bargaining. The case is formally negotiated and settled prior to a hearing.

**Stipulated Surrendered:** The Board agrees to allow the licensee to surrender the license as a resolution to a disciplinary matter. The individual can no longer practice as a respiratory care practitioner in California.

## PRADO, JEREMY TOLENTINO – RCP 28828

Convicted of driving under the influence of alcohol with a prior conviction or driving under the influence of alcohol. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective May 10, 2018.

## **CANOTAL, KRYSTAL ROCIO – RCP 31571**

Convicted of battery upon a police officer and use of alcohol in a dangerous manner. Pursuant to a Decision proposed by an Administrative Law Judge, license revoked, stayed, and placed on three (3) years' probation effective May 22, 2018.

Convicted of two counts of lewd acts with a child under 14 years of age. Pursuant to a Default Decision and Order, license revoked effective May 23, 2018.

## **KRELOFF, SOFORA – RCP 9704**

Committed acts of unprofessional conduct by attempting to sell to the public DME and related accessories without possessing the proper licensure or exemption from licensure with prior disciplinary actions. Pursuant to a Stipulated Surrender of License and Order, license surrendered effective May 27, 2018.

## **RODRIGUEZ, BARBARA – RCP 40297**

Convicted of driving under the influence of alcohol and reckless driving involving alcohol, and revocation of Vocational Nurse license. Pursuant to a Decision proposed by an Administrative Law Judge, unrestricted license denied, however probationary license issued for three (3) years effective May 30, 2018.

## **HARDEN, DOMINICUS – RCP 36620**

Convicted of endangering a child with prior convictions for disturbing the peace and domestic battery. Pursuant to a Default Decision and Order, license revoked effective May 30, 2018.

## **MICHAEL, MICHELLE – RCP 20231**

Committed acts of negligence by failing to provide pre or post-treatment assessments of a patient, unprofessional conduct by failing to follow correct protocols and falsification of medical records. Prior disciplinary action for

committing acts of negligence and unprofessional conduct by failing to provide physician-ordered treatments, charting that she had provided those treatments, and failing to follow hospital policy for obtaining medications. Pursuant to a Stipulated Surrender of License and Order, license surrendered effective June 1, 2018.

## **SWISSA, MOHAMMED ASAAD – RCP 30916**

Committed acts of negligence and a pattern of substandard care by falsely documenting multiple instances of completing in two to four minutes the administration of aerosolized medication via nebulizer, ventilator systems checks, and TIPS weaning, and documenting administering medication via metered dose inhaler to a patient three times in approximately eight hours when it was prescribed to be given only twice a day, or once every twelve hours. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on thirty-five (35) months of probation effective June 14, 2018.

## **MATSON, BRADLEY STEWART – RCP 2755**

Worked in a health care environment while under the influence of alcohol and provided false statement to the Board in regards to compliance with the continuing education requirements. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on five (5) years' probation effective June 14, 2018.
