LIM, JONGWOO EDMONSON - RCP 29513

Convicted of assault with a deadly weapon. Pursuant to a Stipulated Settlement and Disciplinary Order, license surrendered effective April 8, 2022.

Failed to comply with Board-ordered probation by failing to make contact and failing to report for testing, failing to pay costs, and failing to cooperate with the probation monitoring program. Pursuant to a Default Decision and Order, license revoked effective April 20, 2022.

KANG, SANG - RCP 41294

Convicted of driving under the influence of alcohol with a blood alcohol content of 0.08% or higher. Previous conviction for driving under the influence of alcohol with a blood alcohol content of 0.08% or higher. Pursuant to a Default Decision and Order, license revoked effective April 20, 2022.

COOK, MATTHEW THOMAS - RCP 29316

Convicted of driving under the influence of alcohol with a blood alcohol content of 0.08% or higher. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years probation effective May 12, 2022.

MITCHELL, PHILLIP EARL - RCP 32795

Committed negligence by failing to follow a physician's order and adminster the prescribed medication to a patient, falsified or made grossly incorrect entries in a patient's hospital record, and performed unprofessional conduct in administering unsafe respiratory care procedures by charting that he adminstered Atrovert two times during his shift when he did not properly adminster the medication. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on eighteen (18) months probation effective May 19, 2022.

EXPLANATION OF DISCIPLINARY LANGUAGE AND ACTIONS

Effective date of decision: The date the disciplinary decision goes into operation.

Default Decision: A decision based on the licensee's failure to respond to formal charges after it has been served, or failure to appear at an Administrative Hearing. All charges are deemed true. The decision results in the revocation of the license.

Disciplinary Order: An order for discipline adopted by the Board.

Probation: Allows the licensee to practice as a respiratory care practitioner under terms and conditions for a set amount of time.

Proposed Decision: A decision rendered by an Administrative Law Judge through an Administrative Hearing. A proposed decision must be adopted by the Board before it can go into effect.

Revoked: The right to practice is ended due to disciplinary action. The license is invalidated, voided, annulled, or rescinded. The individual can no longer practice as a respiratory care practitioner in California.

Revoked, Stayed: "Stayed" means the revocation is postponed. Professional practice may continue so long as the licensee complies with specified terms and conditions of probation.

Stipulated Settlement: A form of plea bargaining. The case is formally negotiated and settled prior to a hearing.

Stipulated Surrendered: The Board agrees to allow the licensee to surrender the license as a resolution to a disciplinary matter. The individual can no longer practice as a respiratory care practitioner in California.

MACON, ANTHONY LEE - RCP 37145

Convicted of assault with force likely to produce great bodily injury. Perjured license renewal application by failing to disclose the arrest involving the above conviction. Previous conviction for battery. Pursuant to a Default Decision and Order, license revoked effective June 8, 2022.

Failed to comply with Board-ordered probation by failing to obey all laws and abstain from the use of mood-altering substances, and committing a major violation in that she acted in a way that presented a threat to the public and herself. Convicted of driving under the influence of alcohol. Previous convictions for driving under the influence of alcohol and second degree burglary. Pursuant to a Stipulated Settlement and Disciplinary Order, license surrendered effective June 10, 2022.

Convicted of reckless driving, committed a dishonest act and provided a false statement to the Board when completing his license renewal application, and used and administered a dangerous drug(s) and controlled substance(s) in a manner dangerous to himself and others. Pursuant to a Proposed Decision by an Administrative Law Judge, license revoked effective June 30, 2022.
