BROWN, SHAWNDELL – RCP 22246

Committed acts of negligence and unprofessional conduct by failing to assess a patient prior to administering a breathing treatment, failing to remain in the immediate vicinity of the patient while administering a treatment, and failing to document in the patient's medical record. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective October 7, 2017.

ATWAL, PAMPREET KAUR – RCP 31353

Committed acts of negligence and unprofessional conduct by falsifying or making grossly incorrect record entries multiple patient records, failing to perform and document clinically necessary vital sign assessments when administering medication with attendant risks, failing to properly assess or correctly record a patient's heartrate, and documenting the administrative of medication as if given when the patient had already been discharged. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on four (4) years' probation effective October 16, 2017.

CACHO, JOHN PAOLO – RCP 37421

Convicted of petty theft involving a controlled substance, possession of a controlled substance, and revocation of Pharmacy Technician license. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on five (5) years' probation effective October 28, 2017.

BUENAFE, EDRINE PINEDA – RCP 9008

Convicted of possession of a controlled substance with a prior conviction of possession of drug paraphernalia. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on five (5) years' probation effective November 3, 2017.

EXPLANATION OF DISCIPLINARY LANGUAGE AND ACTIONS

Effective date of decision: The date the disciplinary decision goes into operation.

Default Decision: A decision based on the licensee's failure to respond to formal charges after it has been served, or failure to appear at an Administrative Hearing. All charges are deemed true. The decision results in the revocation of the license.

Disciplinary Order: An order for discipline adopted by the Board.

Probation: Allows the licensee to practice as a respiratory care practitioner under terms and conditions for a set amount of time.

Proposed Decision: A decision rendered by an Administrative Law Judge through an Administrative Hearing. A proposed decision must be adopted by the Board before it can go into effect.

Revoked: The right to practice is ended due to disciplinary action. The license is invalidated, voided, annulled, or rescinded. The individual can no longer practice as a respiratory care practitioner in California.

Revoked, Stayed: "Stayed" means the revocation is postponed. Professional practice may continue so long as the licensee complies with specified terms and conditions of probation.

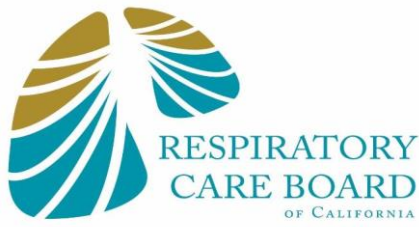
Stipulated Settlement: A form of plea bargaining. The case is formally negotiated and settled prior to a hearing.

Stipulated Surrendered: The Board agrees to allow the licensee to surrender the license as a resolution to a disciplinary matter. The individual can no longer practice as a respiratory care practitioner in California.

BRUNN, MEGAN KATHLEEN – RCP 39811

Convicted of being under the influence of a controlled substance, driving under the influence of alcohol, and solicitation for an act of prostitution. Pursuant to a Stipulated Settlement and Disciplinary Order, license granted, revoked, stayed, and placed on three (3) years' probation effective November 14, 2017.

Convicted of driving under the influence of alcohol on two separate occasions and prior disciplinary action for a conviction of driving under the influence of alcohol and a conviction for entering a dwelling without consent. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on five (5) years' probation effective November 16, 2017.

Convicted of driving under the influence of alcohol with a prior conviction for driving under the influence of alcohol. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective November 16, 2017.

Committed acts of negligence and unprofessional conduct by failing to provide ordered treatment in a timely manner, falsifying or making grossly incorrect or grossly inconsistent entries in hospital records, and failing to conduct follow-up care on a patient. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective November 30, 2017.

Failed to comply with Board-ordered probation by failing to participate in random biological fluid testing, failing to pay probation monitoring and cost recovery, and failing to notify the Board of a change of residence. Pursuant to a Default Decision and Order, license revoked effective December 6, 2017.

Convicted of driving under the influence of alcohol with a prior conviction of reckless driving involving alcohol. Pursuant to a Stipulated Settlement and Disciplinary Order, license revoked, stayed, and placed on three (3) years' probation effective December 7, 2017.
